Economic Impact Stimulus Payment

If you did not receive the Economic Impact Stimulus payment for 2021, you may be able to the claim the Recovery Rebate Credit on your 2021 Form 1040 or Form 1040-SR. Generally, this credit will increase the amount of your tax refund or the lower the amount of taxes you may owe. **Reporting the wrong amount of EIP WILL delay your refund.**

Prior Year Earned Income

The IRS has allowed the use of taxpayer's 2019 earned income to be used to compute the Earned Income Credit (EIC) and Child Tax Credit (CTC) for the 2021 tax year. If you were a 2019 and 2020 Ebuzz/Complete Tax customer, the program will default this information for you. If you are new to Complete Tax, you can either opt out or you will need to provide the following from your **2019** Tax Return: IRS Form 1040, pages 1 and 2, Schedule 1 Additional Income and Adjustments to Income, Schedule 2 Additional Taxes, or Form 8812 Additional Child Tax Credit.
